CALL FOR APPLICATIONS

On the occasion of the Magnum Photos: Colors, Places, Faces exhibition curated by Giorgio Armani and Magnum Photos, Armani/Silos and Magnum Photos are pleased to announce a series of free workshops taking place at Armani/Silos in Via Bergognone 40, Milan.

Each workshop is open to photographers living in Italy, over 18 years of age and of any nationality. There are 30 places in total - 15 places per workshop.

To apply, please submit a PDF including 1 or 2 photo stories with a maximum of 25 images in total, as well as an artist statement. Incomplete applications will not be considered.

Candidates will be selected based on the strength of the work submitted.

Special attention will be given to the quality of the images, the structure of the project and the coherence of the proposal.

Please note the workshop led by Alex Majoli will be in Italian, the one led by Harry Gruyaert will be in English. The workshops are free of charge. Participants will be required to cover their own expenses.

TERMS OF PARTICIPATION IN THE SELECTION PROCESS

ARTICLE 1

Armani/Silos and Magnum Photos are launching a public call for applications lasting 31 days (from 11 November 2022 to 11 December 2022) open to emerging photographers living in Italy, over 18 years of age and of any nationality, aimed at learning and improving their photographic storytelling skills. Selection is based on the quality of submissions.

ARTICLE 2

Armani/Silos and Magnum Photos will select 30 applicants, split into 2 workshops of 15 participants each.

ARTICLE 4

For all applications, the following material must be uploaded using the appropriate application form at: <https://magnumphotos.wufoo.com/forms/sl12kgep00g3wlu/>

Each file can be no larger than 20MB.

Required material:

- An artist statement
- A portfolio in PDF format showcasing 1 or 2 photo-stories with 25 images in total

Applications must be received no later than the deadline given in the call for applications, i.e. 23:59 on 11 December 2022. The person uploading the material shall bear responsibility for the content of the material uploaded and transmitted.

ARTICLE 5

The selection process aims to identify 30 applicants, i.e. 15 per workshop.

The final selection of applicants will be made by Magnum Photos and the workshop photography mentors, following the final assessment of the material sent by the applicants in accordance with the afore-mentioned terms.

ARTICLE 6

The Company, as Data Controller, would like to inform you pursuant to article 13 of the GDPR, that it processes your personal data and that of your employees to perform the contract between the parties and fulfill the obligations it entails; for administrative and accounting purposes; to comply with the legal obligations applicable; to manage the communication with you or your employees. To these ends, the Controller may process personal data such as identification data, contact details, fiscal and banking data. The processing is founded on the following legal bases: performance of a contract or of pre-contractual measures between the parties, compliance with legal obligations, legitimate interest of the controller, consisting in the management of the relationship with you and in the organization of the work. Data processing is carried out by both electronic and manual means according to logics and procedures related and functional to the purposes of processing specified above. Personal data are stored for the entire duration of the contractual relationship between the parties and, after its conclusion, for the time necessary to comply with applicable laws and regulation (e.g. tax laws). For the purposes listed above, providing your data is compulsory. In failure, it may not be possible to start or continue the contractual relationship between the parties.

Your personal data may be accessed by our staff, authorized to process personal data, and by our data processors, duly appointed and instructed on the basis of a specific contract. You can contact the data controller to receive the updated list of data processors. Your personal data may be shared with third parties when the sharing is required by contract or applicable laws and regulations (e.g. to public entities, banks).

If data recipients or data processors are located outside the EU, in countries that do not provide an adequate level of protection of personal data, the Company will take all necessary measures to ensure that data transfer outside the EU is adequately protected (e.g. through the implementation of EU Standard Contractual Clauses). According to article 15 et seq. GDPR, you may request access to personal data and rectification thereof, erasure or restriction of processing, you may object to the processing on legitimate grounds, or request data portability. You may also lodge a complaint with the competent supervisory authority.
